1.目的 General

为规范职业健康安全管理体系认证活动，提高认证有效性，促进职业健康安全管理体系认证工作健康发展，特制定本规则。These Rules are formulated to standardize the certification activities of occupational health management system, improve the effectiveness of certification, and promote the healthy development of occupational health management system certification.

2. 适用范围 Scope

2.1 本规则用于规范依据 GB/T45001-2020/ISO45001:2018 《职业健康安全管理体系要求及使用指南》标准在中国境内开展的职业健康安全管理体系认证活动。The Rules are used to regulate the certification of occupational health and safety management system in China in accordance with GB/T45001-2020/ISO45001:2018 *Occupational health and safety management systems Requirements with guidance for use*.

2.3 本规则是职业健康安全管理体系认证活动中的基本要求，CCATS 在该项认证活动中应当遵守本规则。These Rules are the basic requirements for CCATS in the certification activities of occupational health and safety management system, and relevant bodies shall comply with these Rules in this certification activity.

3. 对 CCATS 的基本要求 Basic requirements for CCATS

3.1 获得国家认监委批准、取得从事职业健康安全管理体系认证的资质。Approved by CNCA and qualified for occupational health and safety management system certification.

3.2 认证能力、内部管理和工作体系符合 GB/T 27021/ISO/IEC 17021-1 《合格评定管理体系审核认证机构要求》。The certification capability, internal management and work system shall comply with GB/T 27021/ISO/IEC 17021-1 *Conformity assessment-Requirements for bodies providing audit and certification of management systems*.

3.3 建立内部制约、监督和责任机制，实现培训（包括相关增值服务）、审核和作出认证决定等工作环节相互分开，符合认证公正性要求。Establish internal restriction, supervision and responsibility mechanisms to separate training (including relevant value-added services), audit and certification decisions from each other, meeting the requirements of certification fairness.

3.4 鼓励 CCATS 通过国家认监委确定的认可机构的认可，证明其认证能力、内部管理和工作体系符合 GB/T 27021/ISO/IEC 17021-1 《合格评定管理体系审核认证机构要求》。The
