1.目的和范围 Purpose and scope

- 1.1 为规范运输服务(陆路运输服务、水运服务、空运服务、支持性和辅助运输服务)认证领域--B2B 城市配送服务认证活动,特制定本实施规则,以确保认证评价的一致性,并符合相关法律及认证认可要求。To standardize the certification field for transportation services (land transportation services, water transportation services, air transportation services, supportive and auxiliary transportation services)--B2B urban distribution service certification activity, this implementation rule is formulated to ensure consistency in certification evaluation and compliance with relevant laws and certification requirements.
- 1.2 本实施规则适用于本公司依据 RB/T 304-2017《B2B 城市配送服务认证要求》开展的 B2B 城市配送服务的认证活动,规定了组织获得和保持 B2B 城市配送服务认证的程序和要求。 This implementation rule applies to the certification activities of B2B city delivery services carried out by our company in accordance with RB/T 304-2017 *Certification Requirements for B2B City Delivery Services*, and specifies the procedures and requirements for organizations to obtain and maintain B2B city delivery service certification

2. 对 CCATS 的基本要求 Basic requirements for CCATS

- 2.1 获得国家认监委批准、取得从事 B2B 城市配送服务认证领域的资质。Obtained approval from the CNCA and obtained the qualification to engage in B2B urban distribution service certification field
- 2.2 认证能力、内部管理和工作体系符合 GB/T 27065/ISO/IEC 17065《合格评定 产品、过程和服务认证机构要求》。The certification capability, internal management, and work system comply with GB/T 27065/ISO/IEC 17065 Requirements for Certification Bodies for Conformity Assessment of Products, Processes, and Services
- 2.3 建立内部制约、监督和责任机制,实现培训(包括相关增值服务)、审查和作出认证决定等工作环节相互分开,符合认证公正性要求。Establish internal restriction, supervision and responsibility mechanisms to separate training (including relevant value-added services), audit and certification decisions from each other, meeting the requirements of certification fairness.
