1.目的和范围 Purpose and scope

- 1.1 为规范物业管理服务认证的实施,特制定本实施规则,以确保认证评价的一致性,并符合相关法律及认证认可要求。To standardize the implementation of property management service certification, this implementation rule is formulated to ensure consistency in certification evaluation and compliance with relevant laws and certification accreditation requirements.
- 1.2 本实施规则适用于本公司依据 GB/T 20647.9-2006《社区服务指南 第 9 部分: 物业服务》、GB/T 39067-2020《商务楼宇公共服务规范》、DB31/T 1210-2020《非居住区物业管理服务规范》等开展的物业管理服务的认证活动,规定了组织获得和保持物业管理服务认证的程序和要求。This implementation rule applies to the certification activities of property management services conducted by our company in accordance with GB/T 20647.9-2006 Guidelines for Community Services Part 9: Property Services, GB/T 39067-2020 Specification for Public Services in Commercial Buildings, DB31/T 1210-2020 Specification for Property Management Services in Non-residential Areas, etc. It stipulates the procedures and requirements for organizations to obtain and maintain property management service certification

2. 对 CCATS 的基本要求 Basic requirements for CCATS

- 2.1 获得国家认监委批准、取得从事服务认证不动产服务认证领域的资质。Obtained approval from the CNCA and obtained qualifications to engage in the field of service certification and real estate service certification
- 2.2 认证能力、内部管理和工作体系符合 GB/T 27065/ISO/IEC 17065《合格评定 产品、过程和服务认证机构要求》。The certification capability, internal management, and work system comply with GB/T 27065/ISO/IEC 17065 Requirements for Certification Bodies for Conformity Assessment of Products, Processes, and Services
- 2.3 建立内部制约、监督和责任机制,实现培训(包括相关增值服务)、审查和作出认证决定等工作环节相互分开,符合认证公正性要求。Establish internal restriction, supervision and responsibility mechanisms to separate training (including relevant value-added services), audit and certification decisions from each other, meeting the requirements of certification fairness.
- 2.4 鼓励 CCATS 通过国家认监委确定的认可机构的认可,证明其认证能力、内部管理和工作体系符合 GB/T 27065/ISO/IEC 17065《合格评定 产品、过程和服务认证机构要求》。The
