## 1.目的 General

为规范环境管理体系认证活动，提高认证有效性，促进环境管理体系认证工作健康发展，特制定本规则。These Rules are formulated to standardize the environmental management system certification activities, improve the effectiveness of certification, and promote the healthy development of environmental management system certification.

## 2.适用范围 Scope

2.1 本规则用于规范依据 GB/T 24001/ISO 14001《环境管理体系要求及使用指南》标准在中国境内开展的环境管理体系认证活动。The Rules are used to regulate the environmental management system certification activities carried out in China in accordance with GB/T 24001/ISO 14001 *Environmental management systems - Requirements with guidance for use*.

2.2 本规则依据认证认可相关法律法规，结合相关技术标准，对环境管理体系认证实施过程作出具体规定，明确 CCATS 对认证过程的管理责任，保证环境管理体系认证活动的规范有效。In accordance with the relevant laws and regulations on certification and recognition, and in combination with the relevant technical standards, the Rules make specific provisions on the implementation process of environmental management system certification, define the management responsibilities of certification bodies for the certification process, and ensure the standardization and effectiveness of environmental management system certification activities.

2.3 本规则是 CCATS 在环境管理体系认证活动中的基本要求，CCATS 在该项认证活动中应当遵守本规则。These Rules are the basic requirements for certification bodies in environmental management system certification activities, and relevant bodies shall comply with these Rules in this certification activity.

## 3.对 CCATS 的基本要求

3.1 获得国家认监委批准、取得从事环境管理体系认证的资质。Approved by CNCA and qualified for environmental management system certification.

3.2 认证能力、内部管理和工作体系符合 GB/T 27021/ISO/IEC 17021-1《合格评定 管理体系审核认证机构要求》The certification capability, internal management and work system comply with GB/T 27021/ISO/IEC 17021-1 *Conformity assessment-Requirements for bodies providing audit and certification of management systems*.
