1.目的和范围 Purpose and scope

- 1.1 为规范运输服务(陆路运输服务、水运服务、空运服务、支持性和辅助运输服务)认证领域--B2B 城市配送服务认证活动,特制定本规则,以确保认证评价的一致性,并符合相关法律及认证认可要求。 To standardize the certification field for transportation services (land transportation services, water transportation services, air transportation services, supportive and auxiliary transportation services)--B2B urban distribution service certification activity, this implementation rule is formulated to ensure consistency in certification evaluation and compliance with relevant laws and certification requirements.
- 1.2 本规则适用于从事 B2B 城市配送服务的组织及其分支机构向本公司申请依据 RB/T 304-2017《B2B 城市配送服务认证要求》开展的 B2B 城市配送服务的认证活动,规定了组织获得和保持 B2B 城市配送服务认证的程序和要求。This rule applies to organizations engaged in B2B urban distribution services and their branches applying to our company for the certification activities of B2B urban distribution services carried out in accordance with RB/T 304-2017 "Certification Requirements for B2B Urban Distribution Services", and stipulates the procedures and requirements for organizations to obtain and maintain the certification of B2B urban distribution services
- 1.3 本规则所涉及的 B2B 城市配送服务,不包括: 危险化学品、冷链食品/物品和专卖商品等特殊要求的配送服务 The B2B urban distribution services covered by these rules do not include distribution services with special requirements such as dangerous chemicals, cold chain food/items and exclusive goods

2. 领域划分 Domain division
